Visa Exemptions	<p>The following nationalities are visa-exempt for tourist and business purposes in Tanzania: Antigua & Barbuda, Anguilla, Ashmore & Cartier Island, Bahamas, Barbados, Bermuda, Belize, Brunei, The British Virgin Islands, British Indian Ocean Territory, Botswana, Cyprus, The Cayman Islands, The Channel Islands, Cocos Island, Cook Islands, Christmas Island, Dominica, The Falkland Islands, The Gambia, Ghana, Gibraltar, Grenada, Guernsey, Guyana, Heard Island & McDonald Islands, Hong Kong, The Isle of Man, Jamaica, Jersey, Kenya, Kiribati, Lesotho, Malawi, Montserrat, Malaysia, Madagascar, Malta, Mauritius, Macao, Mozambique, Nauru, Niue Island, Norfolk Island, Namibia, Papua New Guinea, Rwanda, Romania, Ross Dependency, Samoa, Seychelles, Singapore, Solomon Island, South Sudan, Swaziland, St. Kitts & Nevis, St. Lucia, St. Vincent, St. Helena, South Africa, Trinidad & Tobago, Turks & Caicos, Tokelau, Tonga, Tuvalu, Vanuatu, Uganda, Zambia -, Zimbabwe.</p>
Passport	A valid passport with at least 6 months validity from the date of return from the scheduled trip with at least 3 blank pages at date of submission.
	A certified copy of passport bio-data page.
ID	A certified copy of your ID document.
Application Form	A completed online application form.
Passport Photos	Two (2) recent colour passport photographs.
Flight Itinerary	A copy of a flight itinerary with a return flight to/from Tanzania.
Proof of financial means	Evidence of sufficient funds to cover entire stay in Tanzania.
Yellow Fever Certificate	A certified copy of a yellow fever certificate.
Accommodation	Proof of accommodation such as a hotel booking.
Letter of Invitation	For business applications only, a letter of invitation from the company in Tanzania indicating the nature of your business activities in the country, passport details, and expected duration of stay as well as accepting full immigration responsibility for your stay in Tanzania.
Employer Letter	For business applications only, a letter from your current employer indicating the nature of your business activities in Tanzania and assuming responsibility for any financial, medical, and accommodation expenses.
Processing times	10 – 15 days.
